#### WHAT IS THE RECREATION ACCESS PROGRAM (RAP)?

RAP allows Squamish residents who are in financial need to access Recreation Services and registered programs at a 50% discount. The Recreation Access Card is valid for one (1) year from date of issue.

#### WHAT IS A HOUSEHOLD?

A household is defined as all those living at the same address – including all extended family members of all ages who are related by blood, common law, adoption, or marriage. The same address can include separate living areas in the same house, such as different floors of a multi-unit house or single rooms in a house.

#### WHAT IS GROSS HOUSEHOLD INCOME?

Gross household income is the combined amount of money earned before taxes of all members living in a "household", in Canada and abroad, who contribute to the household. This includes employment income of all types, investments, pensions, spousal and child support payments, rental revenues, funds in trust, disability benefits, overseas income, and all other sources of income.

If you answered YES to all the self-assessment statements, and are within the parameters for gross household income, please continue as you may qualify for RAP.
